CLP and EWM graphs.
CLP treatment was not needed due to lack of detection after the early snow and late ice out.
EWM Treatment:

East Basin – EWM 60 acres treated
West Basin – EWM 13 acres treated

Water clarity is better
CLID has applied for an Anoka County grant for AIS reimbursement for 2023

CLID was awarded a DNR grant of \$10,000 to treat CLP and EWM in Coon Lake

Slide 13 and 14. Proposed Lake Treatment Plan and Cost for 2024 Continue early spring CLP treatment as necessary. Continue EWM spot treatment in East and West Basins. Permit application by January 2024 April or early May CLP treatment, 100 acres @ \$200/acre = \$20,000. EWM treatment, 100 acres @ \$726/acre = \$72,600 New Transect survey or AIS delineation \$5,000 TOTAL: \$92,600

2023 expenses of \$102,800 including administration potential expenses. Motion made by Jeff Welciek and seconded by Becky Beck. Motion passed unanimously.
